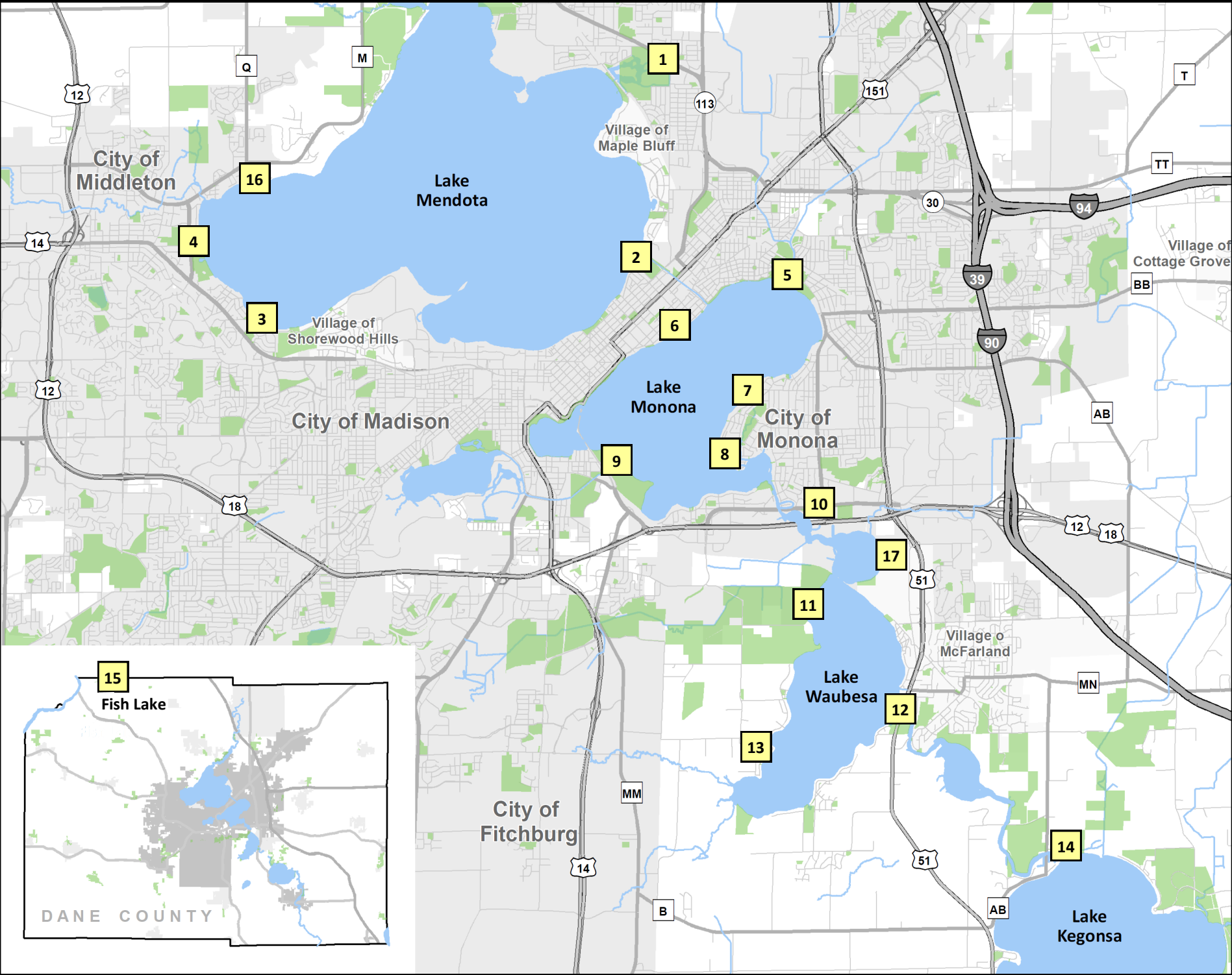

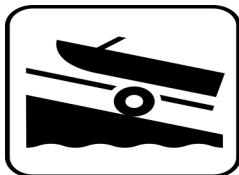

Tips for Safe Boating on Dane County Lakes

RESPECT THE RIGHTS OF OTHER BOATERS

Watch for ALL boats, swimmers and water skiers. Motorboats must yield the right-of-way to non-motorized watercraft.

THINK BEFORE YOU DRINK.

Operating a boat while under the influence of intoxicants is ILLEGAL!

CONTROL YOUR BOAT'S SPEED.

Speed is a major factor in boating collisions. Know the limitations of your boat and how it handles in all sorts of conditions. Be alert for changes in weather conditions. Learn the meaning of waterway marker symbols and dive flags.

WISCONSIN BOATING REQUIREMENTS:

- There must be a U.S. Coast Guard life jacket for each person on board.
- Lights must be ON sunset to sunrise.
- Battery must be covered and secured against shifting.
- Motorboats must be equipped with mufflers.
- Registration must be current and displayed properly.

Please call your local WDNR office for boating regulations.

Lake Access Permit

The Lake Access Permit is a 15-month permit (January 1st through March 31st of the following year) required for all designated launch sites in the City of Madison, City of Monona, and Dane County Parks. Please see the back page for listing of lake access sites.

Lake Access Permits are required year-round.

PARKING VIOLATIONS

Lake access sites are very heavily used. Parking tickets are issued to vehicles that park on the grass, single cars that park in trailer stalls, and vehicles that fail to properly display their Lake Access permits.
